Unless agree in advance, members who leave their boats on the moorings after expiry will be charged a weekly fee until the mooring is vacated.

Parking in the car park is restricted to pontoon members only (and one vehicle per boat). Otherwise, due to our very limited parking, members are kindly asked to park in the village before going out on the water particularly during the busy summer months. Guests must park in the village.
